



**Michigan Radiological Society
Resident & Fellow Section
Application for Executive Board Position**

Prior to the yearly Michigan Radiological Society Resident and Fellows Conference, candidates will be asked to complete an application which will be anonymized. Each application will receive a numerical score (1-10) ranked by select members of the resident affairs committee. The average score will be utilized to rank candidates. The highest-ranking applicant from each program (which applied) will have the "first-choice" in position. The second-highest ranking applicant from each program will have the "second-choice" in position, and so forth. If an applicant's first-choice position has already been filled, they will fill their next choice position until no other positions are available. A second position may not be filled by a member of the same residency program until all residency programs are represented. If there is a tie in applicant score, the chair of the resident affairs committee will make the tie-breaking decision. All winners will be announced at the yearly Michigan Radiological Society Resident and Fellows Conference.

Why are you interested in joining the Michigan Radiological Society Executive Board?

What qualifications do you have for the positions you are applying?

For example, in medical school I served as the University of Michigan Medical School delegate to the Washtenaw County Medical Society executive council. This role entailed participating in these meetings as well as monthly conference calls with the Michigan State Medical Society committee. I am also the current president for the Wayne State University Women in Radiology program. In addition to the skills acquired from this leadership position, this role has given me insight into some of the unique challenges faced by female radiologists, and I think sharing this perspective would be impactful.

What ideas do you have for MRS RFS this year?

If elected onto the leadership committee for MRS RFS, I think having a more virtual presence would be important given that ongoing pandemic restrictions have become the new norm. This could include more of a social media presence which heavily advertises upcoming in-person events and casual zoom meetings that could be inclusive to all radiology residents. As far as more specific collaboration initiatives, I think it would be helpful to create shared google spreadsheets where residents of different programs fill in ongoing research efforts or outreach efforts, for example, that other interested members across programs could get involved in. I personally would be willing to spearhead such an initiative if there is interest.
