## LEGISLATIVE UPDATE

#### OVERVIEW

The Legislature is on break until November 30 for the firearm deer season and the Thanksgiving Holiday. Even after the 2021-22 Budget was passed, there is still nearly \$11 billion which Michigan derived from its share of the federal COVID Recovery dollars from the Trump Administration, and COVID Rescue funds from the Biden Administration. In addition, the State's General Fund is flush due to unexpectedly high tax revenue. At this time, it is believed these excess funds will be appropriated through a series of supplemental funding bills to be enacted later this year into next, and possibly beyond. There now appears to be some consensus among Democrats and Republicans about how to apply the funds. There is also growing momentum for infrastructure and, in particular, a dramatic increase in behavioral health beds, especially for young people. With regard to policy, there are efforts in both Houses to revamp the way behavioral health services are administered. Specialty nurses are at it again attempting to expand their scope of practice which includes ordering and interpreting imaging. MRS leadership is working with MSMS to combat any such effort.

Nurses Seek to Practice Radiology:

SB 680, sponsored by Sen. Rick Outman, (R-Six Lakes) would establish the category of "certified nurse practitioners" (CNP) in statute and would greatly expand their scope of practice. The bill allows a CNP to determine a diagnosis, which is, in essence, the practice of medicine. The bill also allows CNPs to prescribe pharmacological and non-pharmacological "interventions and treatments" that are within their specialty role. Finally, the bill allows CNPs to supervise others and to order, perform, supervise and interpret laboratory and imaging studies. Clearly, this is the practice of medicine and radiology.

MRS will be working with MSMS to defeat this bill.I will be heading up an initial grassroots effort. While this bill just was introduced and is still with the Senate Health Policy and Human Services Committee, it is "all hands on deck" for this one.

#### Radiologic Safety: The Use of Radioactive Materials in Interventional Radiology

Radiologic Safety: The Use of Radioactive Materials in Interventional Radiology

Doctor X is an Interventional Radiologist who uses fluoroscopy and angiography to perform Y-90 embolization. What are the NRC and state of Michigan radiation safety requirements of performing such a case? What fines can be levied against the institution for not being compliant?

The increasing use of radioactive materials in Interventional Radiology has renewed the focus on compliance with regulations governing the use of ionizing radiation. Performing or participating in these procedures involves the use of fluoroscopy and the administration of radioactive materials to patients; examples include liver embolization using yttrium-90 (Y-90) microspheres, lung shunt evaluation using technetium-99m (Tc-99m) microaggregated albumin (MAA), and [procedure] using indium-111 (In-111) [agent]. With this trend, the question arises: what are the regulatory (radiation safety) requirements of performing these cases, and what are the ramifications of non-compliance?

In Michigan, the use of fluoroscopy (and other radiation-producing machines) is regulated by the Michigan Occupational Safety & Health Administration (MIOSHA). The applicable regulations are found in the Ionizing Radiation Rules Governing the Use of Radiation Machines (last revised 2016).

However, the use of radioactive material in Michigan (other than naturally-occurring) is regulated by the U.S. Nuclear Regulatory Commission (NRC). NRC regulations governing the medical use of radioactive material are found in Title 10, Code of Federal Regulations, Part 19 (Notices, Instructions and Reports to Workers), Part 20 (Standards for Protection Against Radiation), and Part 35 (Medical Use of Byproduct Material).

While MIOSHA and NRC regulate different types and uses of ionizing radiation, their protection goals and methods are similar. For example, both require appropriate radiation safety instruction (training) for anyone likely to receive an occupational dose exceeding 100 mrem in a calendar year; this means training is required annually for most interventional radiologists. Both also have similar occupational (and public) dose limits, most notably the annual effective dose limit of 5,000 mrem. However, while MIOSHA regulates only radiation-producing machines, 10 CFR 20.1502(a) contains a subtle but important caveat that allows NRC to bring other activities into its regulatory purview:

#### **ACR/MRS MEMBERSHIP RENEWAL AND INFO ACCURACY**

You should have received your annual ACR membership renewal. Notices were sent late September/early October. The ACR handles the MRS chapter billing also. These dues must be paid before the end of the year. If you have not received your invoice, contact **ACR Membership at (800) 347-7748** now, or you can go the ACR website, login (<u>https://www.acr.org/Login</u>), go to "My ACR" and renew online. If your dues are paid through a group practice or department administrator, still confirm that it has been done; we have had examples where a member wrongly assumed their dues had been paid by a group administrator.

If you have not checked your ACR membership information in the past year or more, I strongly encourage you to do that immediately, especially if you changed employers, membership status, mailing address, or email. MRS receives its membership info from the ACR in periodic updates. If your info is inaccurate, then this will affect whether MRS can contact you. We have had incidents in the past year where members state that they do not receive MRS meeting notices and other electronic communications. You should verify the information in your member Profile now, regardless if you pay dues personally or through a group practice administrator.

#### Fellow of the American College of Radiology

One of the highest honors the ACR can bestow on a member in good standing is recognition as a Fellow of the American College of Radiology. ACR Fellows demonstrate a history of service to the College, organized radiology, teaching, and/or research. Only 15 percent of College members have been awarded this honor. FACR is awarded to diagnostic radiologists, radiation oncologists, interventional radiologists, medical physicists, and nuclear medicine physicians at the convocation ceremony held during the ACR annual meeting.

Fellow of the American College of Radiology is a prestigious award that is conferred by the Board of Chancellors. The Committee on Fellowship Credentials measures each candidate's credentials against the Nomination Criteria rubric where members are not in competition with one another. The CFC forwards its nominations to the Board of Chancellors for its review and approval decisions.

#### Eligibility:

The minimum eligibility requirement is 10 cumulative post-training ACR membership years and at least one criterion among one or more of these domains:

- Service to the ACR at national or chapter level(s) and/or organized radiology/medicine at national, regional, state, or local levels
- Outstanding teaching of diagnostic radiology, interventional radiology, nuclear medicine, radiation oncology, and/or medical physics
- Significant scientific or clinical research in radiology or significant contributions to the literature

There are two ways to apply for FACR.
