The annual meeting of the Chapter shall be held <u>after the Annual Meeting of the American College of Radiology at</u> such time during the month of May and at such place as shall be selected by the Board of Trustees. Notice of the exact time and place of such meeting shall be physically or electronically mailed to the members of the Board of Trustees no fewer than fifteen days prior to such date. Additional regular meetings may be scheduled by the Board of Trustees, and notice of the time and place thereof shall be physically or electronically mailed to the members of the Board of Trustees no fewer than fifteen days prior to any such scheduled meeting.

Section 2

Special meetings of the Chapter shall be called: (a) by the President when deemed necessary by the Board of Trustees; (b) at the request of the American College of Radiology; or (c) by petition of one-third of the voting members in good standing or by thirty such members, whichever is less. Notice stating the time, place and purpose of the meeting shall be physically or electronically mailed to each member at least ten days prior to the meeting. At a special meeting, no business may be transacted except that for which such special meeting was called.

Section 3

A quorum shall consist of the number of voting members of the Chapter present.

ARTICLE X - STANDING RULES

Sturgis's Standard Code of Parliamentary Procedure shall be the authority governing all business meetings of the Chapter, unless otherwise provided in these bylaws.

ARTICLE XI - DUES AND ASSESSMENTS

All active and associate members, and affiliate members shall pay dues in an amount based upon budget prepared by the Board of Trustees and approved by the members at the annual meeting. Members in training and retired, members shall not pay dues. Admission to membership and continuation of membership shall be contingent upon the payment to the Association of such dues and assessments as may then be in force.

Assessments of dues-paying members may not be levied except upon recommendation of the Board of Trustees and by a majority vote at the annual meeting of the Chapter, notice of such recommendation having been sent to each such member no fewer than ten days prior to the meeting.

Names of members in arrears in payment of dues or assessments shall be referred to the Board of Trustees for action. If dues have not been paid by the deadline set forth in the annual dues invoice, notification shall be given by letter to the delinquent member that if said dues are not paid within thirty days, the member's name shall be stricken from the rolls of the Chapter and the College. Such former member shall be eligible for automatic reinstatement upon payment of current dues and the previous year's dues (if unpaid) and upon certification of Chapter membership.

Any member suffering serious financial hardship or long-term illness may request a waiver of dues for the year. All such requests must be made in writing and directed to the Board of Trustees. All waivers of dues for financial hardship of illness are at the discretion of the Board of Trustees. Any members making such requests will be notified in writing of the decision reached. If difficulties in payment of dues persist more than that calendar year, a written request must be submitted each subsequent year.
